1. महाविद्यालय द्वारा सत्र 2016-2017 में नियुक्त प्राचार्य डॉ. सुबिया खान शिक्षा में पी.एच.डी. उपाधि धारक एवं 06 वर्ष की शैक्षणिक अनुभवधारी को प्राचार्य के रूप में नियुक्त दर्शाया गया है। जो कि एनसीटीई के नवीनतम मानदण्डानुसार निर्धारित 08 वर्ष का शैक्षणिक अनुभव नहीं होने के आधार पर एनसीटीई के मानदण्डानुसार निर्धारित योग्यताधारी नहीं है। निर्धारित योग्यताधारी प्राचार्य की नियुक्ति किया जाना सुनिश्चित करें।
2. महाविद्यालय में सत्र 2016-2017 में नियुक्त शिक्षकों में से शिक्षक हरिप्रसाद के अतिरिक्त शेष शिक्षक यूजीसी/ विश्वविद्यालय नियमानुसार शिक्षा में नेट/सेट उत्तीर्ण नहीं है।
3. महाविद्यालय बी.एड. पाठ्यक्रम (200 सीटों) हेतु एनसीटीई के नवीनतम मानदण्डानुसार अतिरिक्त आधारभूत सुविधाओं की उपलब्धता सम्बन्धी दस्तावेज भिजवाया जाना सुनिश्चित करें।
4. महाविद्यालय सत्र 2016-2017 में उक्त पाठ्यक्रम में प्रवेशित विद्यार्थियों की यूजीसी के नियमानुसार कालांश व उपस्थिति की अनिवार्यता सुनिश्चित करें।
5. महाविद्यालय को NAAC द्वारा तैयार की गई नई क्रम निर्धारण प्रणाली (Grading System) के अधीन ग्रेड बी सहित प्रत्यायन कराना आवश्यक है। अन्यथा इस सम्बन्ध में एनसीटीई द्वारा की जानेवाली कार्यवाही के लिये महाविद्यालय प्रशासन उत्तरदायी होगा एवं प्रवेशित छात्रों से सम्बन्धित किसी भी प्रकार के विवाद की सम्पूर्ण जिम्मेदारी महाविद्यालय प्रशासन की होगी।

The application for extension in provisional affiliation for the session 2017-2018 along with required fee may be sent together with a report about the fulfillment of the conditions of the provisional affiliation up to 31st Dec.2016. If already deposited, need not to deposit.

The Provisional affiliation is subject to the following conditions:-

- I To follow and observe the University Act, Statutes, Ordinances, Regulations, Rules and Instructions framed, amended, adopted and issued from time to time relating to:-
 - (a) Admission of only eligible students allotted through Coordinator will be made.
 - (b) To follow curricular courses of study as prescribed by the University from time to time including scheme of examinations and conduct of examinations.
 - (c) Appointment of qualified Teaching/Technical support staff/supporting staff within stipulated period as per the NCTE norms.
- II
 - (i) Staff- Appointment of permanent and qualified Principal and teaching staff on full time basis selected by duly constituted committees as per norms of the NCTE, UGC and the University and appointment will be got approved from the University.
 - (ii) Building - Construction of sufficient building and infrastructure, play grounds and hostel building etc. as per the provisions of the NCTE norms.
- III Library- As per the norms of the NCTE year-wise development of college Library and provision of funds for journals and magazine be made. Year wise bifurcation of books purchased-details be submitted.
- IV Endowment Fund- Sufficient endowment fund as prescribed in rules be created & University will be supplied a copy F.D.R. etc. in the name of Registrar & Management Committee.
- V Faculty members- Appointment of faculty members as per the norms of NCTE be made.
- VI
 - (a) Number of admission will be restricted to the number of seats allotted by the University. No admission over and above the number of seats allotted will be made.
 - (b) No admissions may be given in the subject(s)/course(s) without obtaining the affiliation in the subject(s)/course(s) concerned.
Non compliance will entail severe action against the college as per the letter No. 31170-313 dated 23-02-2006 and responsibility for the same will be with the College Administration.
- VII In case of non compliance or failure to observe the conditions of the affiliation, the college will be liable for the penalty and action as per the Notification No. 18349 dated 22.5.2012.
